ORDINANCE NO. 81-

AN ORDINANCE ADOPTING RULES AND REGULATIONS
IN RECREATION AREAS OF FAWN GROVE BOROUGH
AND IMPOSING PENALTIES FOR THE VIOLATION
THEREOF .

It is hereby enacted and ordained by the Borough Council
of Fawn Grove Borough, York County, Pennsy Ivania as follows:

Section 1. Rules and Regulations. All recreation areas in
Fawn Grove Borough which are owned, leased, or operated by the
Borough shall be subject to rules and regulations of the
Borough as follows:

A. All parks will be closed at a time designated by the
Borough or by the organization to whom the park or portion
thereof is leased and all supervised activities must terminate
at said time, but in no event shall there be any activity by
any organization continuing beyond 1:30 a.m. without specific
approval by the Borough.

B. No alcoholic beverages shall be allowed except when
supervised by the leasing organization and in no event shall
any alcoholic beverages be allowed outside any building after
dusk.

C. All activities upon the park grounds taking place
after dusk shall be supervised by a responsible adult.

D. No glass containers of any kind shall be allowed
on the park premises.

E. E. The operation of motorized vehicles shall be limited
to the driveway and parking areas.

F. There shall be no littering. All trash and litter
shall be deposited in containers provided.

G. Entry to any buildings except by invitation by the
leasing organizations or Borough is restricted except during
sponsored activities.

H. Negligent or deliberate destruction, or removal of
natural or physical property is forbidden.

I. Outdoor recreation activities shall be restricted to
locations appropriate to said activity.

J. No one shall be under the influence of alcoholic beverages or drugs in any park area.

K. Use of explosives, fireworks, guns, slingshots, air guns, bows, or any similar items is prohibited unless said use is part of a sponsored activity.

L. There shall be no boisterous, immoral or indecent conduct in any park area.

Section 2. Penalty. Any person, firm, or corporation which shall violate any of the provisions of this ordinance or any appropriate order of Borough personnel I pursuant to the rules and regulations ordained hereby, shall, upon conviction thereof, be sentenced to pay a fine of not more than \$300.00 and, in default of payment thereof, to imprisonment for not more than thirty (30) days.

Section 3. Severability . If any provision, section, sentence, clause or part of this ordinance shall be held invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this ordinance.
